# **Memorandum of Association**

(A society registered under the Societies Registration Act No. XXI of 1860 as applicable to the National Capital Territory of Delhi)

#### 1. Name: "PACHPAN ALUMNI WELFARE ASSOCIATION"

The name of the Society is **PACHPAN ALUMNI WELFARE ASSOCIATION** an Association / Society of all those who joined National Defence Academy and were a part of 55<sup>th</sup> NDA Course during the year 1976 to 1978.

### 2. Registered Office:

The registered office of the Society, at present, is situated at

- S-69, Greater Kailash 2, Greater Kailash, South Delhi, Delhi -110048
- 3. The Society will operate on all India basis.

#### 4. Aims and Objects

The basic aims and objects for which the Society is formed and registered are the following:-

- (v)To open branches where ever considered expedient for the promotion of above objects.
- (vi) To subscribe or give donations, financially or otherwise, to such other societies, agencies, associations or institutions who are working in the area of social welfare or involved in the activities which tend to support or aid / advance the aims and objects of the society.
- (vii) To receive any grant, donation, fee, support and assistance in any form for the furtherance of the objects of the society.
- (viii) To frame bye-laws and rules and regulations for the conduct of the business of the Society and its officers and employees.
- (ix) To do all such other lawful acts, deeds and things as are incidental or conductive to the attainment of the above objects or any of them.

(x) All the income, earnings, moveable properties of the society shall be utilized and applied towards the promotion of its aims and objects only as set forth in the "Memorandum of Association" and no profit or part thereof shall be paid or transferred, directly or indirectly by way of dividends, bonus, profit or in any manner whatsoever, to the members of the society or to any other person. No member of the society shall have any personal claim on any moveable or immovable properties of the society or make any profits, whatsoever, by virtue of this membership.
